#### BOARD OF DIRECTORS NOMINATIONS

Nominations for Directors of the Board closed at 5:00 pm on November 15, 2017. Four candidates were nominated for four vacant positions. Therefore, the Directors will be elected by acclamation at the AGM. Of the four Board positions, three are for a 3-year term and one is for a 1-year term. The new Directors will decide from among themselves who will occupy the 1-year term position.

The following comments are from each candidate by way of introducing themselves to you. The candidates in alphabetical order are:

### (1) Doug Bell

Seconders: Betty Pearson and Cheryl Bancroft

LMS is a remarkable organization that contributes very significant volunteer energy and expertise to our community. In addition, LMS initiatives provide for unprecedented levels of marine tourism spending in our community. Our future is potentially very bright.

I believe LMS is at a fork in the road with respect to our future. Our lease will expire in 12 years and the current joint Town – Stz'uminus First Nation waterfront planning work is well underway with a time frame much longer than 12 years. This work has the potential to fundamentally shape the future of LMS however LMS is not a significant participant in this work.

Excellent relationships with LMS employees and members, moorers, citizens of both communities and funders are essential to securing our future. I am prepared to diligently contribute to improving these relationships and in the process work towards further securing our future potential in the harbour and with both the Town and Stz'uminus First Nation.

## (2) Barrie McDonald

Seconders: Gerry Beltgens and James Phillips

LMS' facilities, expert staff, and incredible volunteers are widely recognized throughout the Pacific NW as the best there are. Our many activities that welcome members of the community down to enjoy their own waterfront have earned the appreciation of local residents. Local businesses benefit significantly form the visitors we attract.

But in addition to its on-going activities and capital programs LMS is now facing a situation that may well determine its future as an organization. That is the opportunity to serve our community through proactive participation with the Town of Ladysmith and the Stz'uminus First Nation in implementation of the community's waterfront plan. The consultant's final report is expected before Christmas. Fumbling this opportunity would lessen the relevance of LMS in the community. And it could jeopardize the longer term tenure of LMS on the waterfront.

Securing the future of LMS, together with strengthening a culture of support and mutual respect across our organization, requires leadership. And that starts with the Board. Over the past ten years I have served on your Board for six years (2007-2013) and on special project teams for the past four years. LMS is a very important contributor to our community. And I hope we can keep it that way.

#### (3) Peter MacHardy

I retired in 2014 with 46 years of experience to start up my own consulting business PEMAC & Associates yet still enjoy the benefits of retirement & life on the island. My career spans across administration, project management, property management, occupational health & safety, strategic planning and team building. Over my career, I have sat on numerous not-for-profit boards: Habitat for Humanity, Missing Children Society of Canada, various condo boards and commercial real estate boards. I currently sit on the Ladysmith Chamber of Commerce Board, Ladysmith Family & Friends Board and the BOMI Canada Board in Toronto.
