## 30<sup>th</sup> AGM

Fifty-eight members in good standing and guests attended Ladysmith Maritime Society's 30<sup>th</sup> Annual. General Meeting on December 3, 2015.

A resolution to amend the Constitution was successfully passed by over 90% of those eligible to vote. This amendment adds educational aspects to our purposes. Once accepted by the Registrar of Companies, Section 2 (a) will state:

- 2. The purpose of the Society is to serve the community in the following ways:
- (a) protecting and promoting Ladysmith's maritime heritage including
- (i) the development and operation of a maritime museum
- (ii) fostering expertise in the construction, maintenance, and restoration of heritage boats
- (iii) providing education, educational programs and educational materials to the public.

October 15 approximately 100 volunteers enjoyed a roast beef dinner catered by Fox & Hounds. The LMS Welcome Centre doesn't have that many chairs! Fortunately the weather co-operated and many sat down at the picnic tables.

This was an opportunity to say "thanks" to our army of dedicated volunteers. To the ones who were unable to attend, we are sorry you weren't there. LMS would not be able to provide the services to the community that our Constitution mandates without the assistance of all our volunteers. Our appreciation extends far beyond "thank you".

#### **OCTOBER MEMBERS MEETING**

Our Treasurer, David Grimstead, presented several good news stories of a monetary nature.

- Visitor moorage was over \$80,000
- \$100,000 was paid against the loan in Oct. there is still \$77,000 owing.
- A balanced budget for the 2015-2016 fiscal year was presented.
- There will be no increase in moorage fees next April.

Debbie Loewen gave a report on last summer's "opt-in" program. This was a program to share 50% of visitor moorage received when visitors were moored in annual moorers' slips. \$3,249.88 was distributed amongst those who "opted in"

New parking regulations were discussed. No overnight parking will be allowed in the lower parking lot; and no parking will be allowed along the water side of the lower lot. These rulings came into being after a walk-about by Ladysmith's Fire Chief. You will see new signage to this effect.

#### MOORAGE CONTRACTS

For those members who are also moorers, contract season is coming up. There will be a few changes in the details – the good news is that the price will be the same as last year.

The contracts will be sent via email to as many as possible. Snail mail is slower and more costly. Expect them mid - end of January.

#### **DID YOU KNOW**

LMS was incorporated as Ladysmith Tall Ships Society on July 26, 1985.

The name was changed to Ladysmith Maritime Society in 1991.

95 members have served as directors over the 30 years.

From 3 pairs of purple martins in 1989 our colony now hosts over 80 pairs - the most successful colony in Georgia Strait.

In 2015 LMS achieved 3 anchors (out of a possible 5) from the Georgia Straight Alliance Clean Marine program.

The 2015-2016 budget is over \$700,000.
